Requests received after March 31, but not later than June 30, 2011, will be processed on an as received basis with presentations of Citations made at a club meeting.

Submission of supporting materials with the request is not required.

**2010-2011 District Governor's Citation**

To qualify for this citation a club must (1) have applied to receive or received either a 2010-2011 Presidential Citation or a 2010-2011 Presidential Citation with Distinction and (2) meet the requirements contained in Part 2 of the request form, and (3) complete the number of activities indicated for this citation for each of the subparts in Part 3 of the request form.

**2010-2011 District Governor's Citation with Distinction**

To qualify for this citation a club must (1) have applied to receive or received a 2010-2011 Presidential Citation with Distinction, (2) have a net increase in membership (baseline is the number of club members as of July 1, 2010), (3) meet the requirements contained in Part 2 of the request form, and (4) complete the number of activities indicated for this citation for each of the subparts in Part 3 of the request form.
